TERMS AND CONDITIONS OF ENTRY – *please read carefully.*

1. PRIZE

The Judge to select one artwork for the major prize of \$6,000, sponsored by BDO Bay of Islands Chartered Accountants and Advisers. A Peoples Choice Award will also be awarded to the value of \$2,000. This will be selected by public vote and presented on the last day of the exhibition. This Award is also sponsored by BDO Bay of Islands Chartered Accountants and Advisers (www.bdo.co.nz).

The Judge will select a further two highly commended artworks. Prizes are product to the value of \$500, sponsored by The French Art Shop (www.thefrenchartshop.co.nz) and Living Nature (www.livingnature.com).

2. JUDGE - John Gow

John is Owner - Co-Director of the John Leech Gallery in Auckland, New Zealand's earliest dealer gallery established in 1885. He is also Owner – Co-Director of the Gow Langsford Gallery, also in Auckland. Other involvement in the arts sector include being a past advisor to the Arts Council in Wellington and founding member of the Art Dealers Association in Auckland. John was the 2007 judge. 3. HOW TO ENTER

- (a) Complete an application on the official entry form (following).
- (b) Entry forms are available either as a hard copy, can be downloaded from www.kerikeri.co.nz or can be emailed to you. Please phone 021 344 870 or email northlandartscomp2010@xtra.co.nz.
- (c) The entry fee is \$40.00 for the first entry and \$25 per subsequent entry. There is a maximum of three entries per person. Payment can either be made by cheque, made out to 'ArtsXL Charitable Trust' or deposited directly into ArtsXL bank account (ASB Kerikeri 123091 0186659 00, please include your name as reference).
- (d) Title of work, size of work, name, address, telephone number and price must be clearly written on the entry form. A short bio on yourself, as the artist, should also be included.
- (e) A clear coloured photo or digital print of your work (unmounted), with top clearly marked, name of work on back, no larger than A4, must be sent as a part of the entry. If you wish this to be returned to you at a later date, also enclose a stamped addressed envelope of the appropriate size.
- (f) Send the competition entry, payment and photo to Tania McInnes, c/o BDO Bay of Islands, P O Box 304, Kerikeri. The entry must be received before 5pm on the closing date of 15 October 2010.
- (g) A high resolution picture of the work/s is also to be *emailed* by 15 October to northlandartscomp2010@xtra.co.nz for pre judging.

4. CONDITIONS OF ENTRY

MEDIA. For the purpose of this competition, the definition of drawing/painting category is as follows:

Essentially two dimensional work using primary or secondary hand made marks in any medium excluding solely photographic or mechanically/digitally produced images.

SIZE OF WORK: Work may contain no more than three separate pieces, provided the area does not exceed 1200mm x 1200mm; no deeper than 100mm.

HANGING: Work can be framed or unframed, but must be able to be hung, or supported sufficiently to allow for substantial screw eyes and or eyelets.

ANY ENTRY WHICH DOES NOT MEET THESE CRITERIA WILL NOT BE ACCEPTED .

5. A maximum of 80 entries will be chosen to be exhibited. There will be an initial prejudging process, from which the 80 works will be selected. The exhibition will be held at The Centre at Kerikeri from 14 to 21 November 2010.

6. FINALISTS

All entrants will be advised as soon as possible by 29 October, whether they have been chosen to present their work for the exhibition. If selected they will be asked to forward their work/s for hanging and final judging. All exhibitors will receive a complimentary ticket to the opening.

7. All works *must* be for sale. Prices are to be shown on the entry form and must be GST inclusive. No works will be sold prior to the judges announcement at the opening ceremony. ArtsXL's commission rate will be 30% excluding GST.

Example: \$1,000 selling price
 \$300 commission at 30% commission
 \$700 to artist

Where appropriate, the artist must include their agents fee in the selling price. Prize money is not acquisitive of winning piece. All sold work must stay on display until 21 Nov 2010.

8. All work is to be signed, dated and clearly labelled and must have been completed between 2009 and 2010. It must *not* have been previously exhibited.

10. The Judges decision will be final. No correspondence will be entered into.
11. ArtsXL reserves the right to reproduce the works for advertising purposes in any form, for any catalogue or other publicity of our choosing. There will be no entitlement to royalty or other payment for any reproduction.
12. ArtsXL, as a fundraising exercise, may produce a 2011 calendar, in which works from this exhibition may be chosen to feature. ArtsXL reserves the right to reproduce the works for this purpose. There will be no entitlement to royalty or other payment for any reproduction.
13. This Award is open to any person residing in Northland, this area being determined by NZ Post Northland postal areas Wellsford North.
14. ArtsXL takes all care, but accept no responsibility for any loss or damage which may occur. Artists should arrange their own insurance (on loan).
15. All works must be packaged in secure packing materials to ensure safe handling and trans-shipment. (We suggest a firm cardboard box to protect your valuable asset). Please note, the size of the packaged work determines the freight value, NOT the size of the work itself. Please place your name and address on the outside of the packaging so your work can be readily identified.
16. Selected works for exhibition are to be delivered to The Centre at Kerikeri, 43 Cobham Road, Kerikeri on either **Friday 12 November, between 10am and 4.30pm or Saturday 13 November, between 9am and 2pm.**
17. **FREIGHT**
All freight to and from the competition shall be the responsibility of the artist. Artists whose work is chosen to be forwarded to us should enclose, with the work, a cheque made payable to 'ArtsXL Charitable Trust' to cover costs for return of the work following the exhibition. (The cheque will be destroyed if not required).
